## **Village Footpath Volunteers**

Simon Lang (for the footpaths north of the Lamyatt High Street) and Paul Chadwick (for those south of the village High Street) will check footpaths & bridleways but any resident that sees a damaged finger post, stile, gate or bridge or dangerous bridleway or impassable right of way should notify the County Council team direct using their website. There are a range of Village volunteers looking after specific stiles/sections of path too by cutting back brambles or using a strimmer every so often— can you help?

It is hoped that there can be an annual village walk across some of the footpaths.

**(02/08/2019) Footpaths** – Many thanks to those in the village who help look after a footpath or a stile adjacent or close to where they live by clearing away the nettles or overgrowth that can occur. There has been some work by Merv Walters to improve the drainage in the field behind the Church going up to the top of Portway Hill, no doubt in readiness for planting. A side benefit of this is that the footpath up that hill will be drier underfoot, as will be the one going from the Church to the back of the village hall. **22/11/2018) Footpath Re-opens**: The footpath which used to go under the old Somerset & Dorset railway tunnel was re-opened in October 2018 following the bulldozing of the tunnel. It's again possible to reach the 'Natterjack' across the fields on this route. (photo 21/11/2018).

**(04/10/2018) Footpaths:** many thanks to all the volunteers who have helped to keep various footpaths and bridleways open this past summer by clearing around a stile or removing obstructions. The Trustees of the Alms House have been asked to

formalise the situation regarding the obstruction of footpath SM13/9 (as raised at the Parish meeting).
